Summary

Dr Bird is a highly skilled and experienced Consultant Clinical Psychologist with expertise in expert witness work, Autism Spectrum Disorder (ASD) assessments, and various additional clinical areas. He provides accurate assessments and targeted support strategies for individuals and families affected by ASD and related developmental disorders. He has developed a range of specialisms in the medicolegal field and undertakes assessments in the context of both public and private law. Since 2008, Dr Bird has completed over 500 assessments for the Family Court and given in-person and remote testimony on many occasions.

Values and Approach

Dr Bird prioritises the core values of empathy, openness, authenticity, and relationship-building in his work as a Clinical Psychologist. He believes that fostering genuine, trusting connections with clients is crucial for delivering effective and meaningful outcomes in both clinical and legal fields. By creating a positive rapport, and focusing on the perspectives of the client, he enables individuals and families to openly discuss their experiences and challenges in ways that enhance the validity of his clinical opinion.

In addition to his emphasis on the therapeutic/working relationship, Dr Bird brings academic and clinical rigour to his work. He stays up-to-date with the latest research and developments in his areas of expertise, ensuring that his practice is informed by evidence-based approaches where relevant. This allows him to provide a high quality of input, tailored to each client's unique needs.

Expert Witness Assessment

Dr Bird has been providing expert witness assessments to the Family Courts since 2008 and offers indepth psychological assessments of adults and children in public and private law proceedings. More recently, he has developed specific expertise in assessing the dynamics underpinning Child Arrangements disputes following parental separation. Dr Bird has developed a strong understanding of how children present within these complex and conflictual situations, and the ways in which the dynamics within the parental relationship continue into legal proceedings. His assessments consider how parents' own experiences across their lifespans, particularly in childhood, might be relevant to the issues before the Court. He synthesises complex information from multiple sources, considering a) parental mental health and personality profiles, b) the cognitive and emotional styles of multiple



parties, c) the impact of developmental trauma on children and adults, and d) the relevance of intergenerational patterns in shaping parental attitudes and behaviours.

Dr Bird has now completed over 500 expert witness reports and received consistently positive feedback about the quality of his work, his engagement with families, and the usefulness of his reports to the Court in resolving complex and intractable issues. He has maintained and developed strong relationships with local clinicians and professionals in partner agencies. He always aims to provide practical rather than 'ideal world' recommendations for therapy and additional support that are not either available or suitable for the individuals involved. He provides clear testimony in legal hearings and has received consistently positive feedback from senior Judges regarding clarity and balance.

Autism Spectrum Disorders and related Neurodiversities

Dr Bird has provided independent assessments of Autism Spectrum Disorders and other forms of neurodiversity since 2010, most recently under the banner of Bird & Jones Autism Assessments alongside Dr Jonathan Jones (Consultant Clinical Psychologist). He uses a range of standardised and bespoke clinical assessments to generate developmental profiles for children and adults, which can then be used to access support systems and identify further resources. Dr Bird has increasingly been instructed to assess the role of ASD within public and private law proceedings and has completed diagnostic assessments of ASD in those contexts.
